RESOLUTION REJECTING ALL BIDS, APPROVING REVISION OF PLANS AND SPECIFICATIONS, AND CALLING FOR BIDS FOR THE MISSION BOULEVARD CORRIDOR IMPROVEMENTS PHASE 3 PROJECT, PROJECT NO. 05287

WHEREAS, by resolution on July 21, 2020, the City Council approved the plans and specifications for the Mission Boulevard Corridor Improvements Phase 3 Project, Project No. 05287, and called for bids to be received in September 2020 contingent on receipt of utility drawings & temporary construction easements; and

WHEREAS, on March 24, 2021, Addendum No. 1 was provided to respond to bidder questions.

WHEREAS, on March 31, 2021, Addendum No. 2 was provided to respond to bidder questions.

WHEREAS, on April 6, 2021, two bids were received, ranging from \$12,833,938 to \$14,014,014; Ghilotti Construction Company of Santa Rosa, California submitted the low bid in the amount of \$12,833,938, which is 27% above the Engineer's Estimate of \$10,127,039.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hayward that the above listed bids, and all other bids for the Project are hereby rejected.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to return the bids and bid bonds submitted by all bidders.

BE IT FURTHER RESOLVED that Addenda Nos. 1 and 2 are hereby approved and adopted as part of the revised plans and specifications for the project.

BE IT FURTHER RESOLVED that those certain revised plans and specifications for the Mission Boulevard Corridor Improvements Phase 3 Project, Project No. 05287 will be on file in the office of the City Clerk, are hereby to be adopted as the plans and specifications for the project.

BE IT FURTHER RESOLVED that the City Clerk is hereby directed to cause a notice calling for bids for the required work and material to be made in the form and manner provided by law.

BE IT FURTHER RESOLVED that sealed bids therefore will be received by the City Clerk's office at City Hall, 777 B Street, Hayward, California 94541, up to the hour of 2:00 p.m. on Tuesday, September 14, 2021, and immediately thereafter publicly opened and declared by the City Clerk at City Hall, Hayward, California.

BE IT FURTHER RESOLVED that the City Council will consider a report on the bids at a regular meeting following the aforesaid opening and declaration of same.
