- (E-88) - Municipal Resolutions (calling election, ballot measure questions, ballot measure full text, City Attorney Analysis)
- (E-84) - Official Candidate List & Candidate Statement of Qualifications
(in the case of no seat extensions)
- (E-82) - Official Candidate List & Candidate Statement of Qualifications
(extension deadline – if applicable)
- (E-71) - All Direct Arguments and Rebuttal Arguments

If any resolutions necessitate special requirements that the Elections' Office needs to fulfill, such requirements need to be listed in the resolution.
