













SCOPE OF SERVICES

- OPTIONS: OPERATIONAL RESPONSIBILITY
 - ADMINISTRATIVE ONLY W/ OPERATIONAL PARTNERS
 - "LEAD" OPERATOR W/ "TENANT" SUB-OPERATORS
 - DIRECT OPERATIONAL RESPONSIBILITY FOR ALL SERVICE DELIVERY
- OPTIONS: FACILITY-RELATED RESPONSIBILITY
 - DIRECT RESPONSIBILITY FOR FACILITY UPKEEP AND REPAIR
 - PAYMENT OF RENT and/or COLLECTION OF RENT FROM "TENANT" PARTNERS
 - PAYMENT INTO A MAINTENANCE FUND

QUALIFICATIONS

- Options: ORGANIZATIONAL TYPES
 - PUBLIC or PRIVATE
 - NONPROFIT or FOR-PROFIT
 - SINGLE AGENCY or PARTNERSHIP
- Required information: ORGANIZATIONAL CAPACITY
 - CURRENT OPERATING BUDGET? CURRENT ASSETS? FISCAL AUDIT?
 - CURRENT STAFFING CAPACITY?
 - LENGTH OF APPLICABLE EXPERIENCE?
- Additional desired QUALIFICATIONS
 - LOCAL FOOTPRINT/ EXPERIENCE
 - REGIONAL AND/OR NATIONAL EXPERIENCE
 - INVESTMENT/ REVENUE/ COST-SHARING CAPABILITY

INVESTMENT & PARTNERSHIP

- WHAT FINANCIAL INVESTMENT, IF ANY, CAN FACILITY OPERATOR PROVIDE?
 - CAPITAL INVESTMENT?
 - OPERATING FUNDS?
 - PAYMENT OF RENT?
 - CONTRIBUTIONS TO A FACILITY MAINTENANCE FUND OR OPERATING FUND?
 - OTHER FINANCIAL INVESTMENT AND/OR PARTNERSHIP?
- APPROX. \$16.8M IN CAPITAL FUNDING SECURED TO DATE
- ACTUAL CONSTRUCTION COSTS DEPEND ON EXACT DESIGN, FUNCTION
- SITE-SPECIFIC DESIGN, CONSTRUCTION COST ESTIMATE IN DEVELOPMENT
- ESTIMATED TOTAL PROJECT COST: \$26M+
- NO OPERATIONAL FUNDING YET IDENTIFIED

SELECTION PROCESS

INSTRUMENT

 CITY OF HAYWARD WILL ISSUE A REQUEST FOR QUALIFIACTIONS (RFQ) ON BEHALF OF THE CITY/COUNTY/HARD PARTNERSHIP

REVIEW PROCESS

- PANEL COMPRISED OF TWO STAFF PERSONS EACH FROM CITY/COUNTY/HARD
- PANEL REVIEWS RESPONSES, REQUESTS INFO AS NEEDED
- PANEL PRESENTS RESPONSES TO GOVERNANCE GROUP

PROPOSED RFQ TIMELINE:

– AUGUST 1: RFQ ISSUED

SEPTEMBER 15: SUBMITTAL DEADLINESEPTEMBER 20-24: STAFF REVIEW PANELS

SEPTEMBER 26: PRESENT RESPONSES TO GOVERNANCE GROUP
