- In 1960s, approximately ~32,000 births and deaths per year
 - Every birth and death in AC would need to be manually searched
- Other sources
 - Yearbooks: have not been able to locate (City of Hayward Library, Alameda County Library, San Lorenzo School District (still waiting on callback), Hayward Historical Society)
 - LA library guide to vital records
 - Familysearch.org: no unique Russell City identifier; 1960: 263,516 records for "Hayward"
